At the close of discovery, the parties may either pick a jury and then have a trial by jury or the case may proceed as a bench trial.: If evidence of authenticity is lacking in a bench trial, the trial judge will simply dismiss the evidence as unpersuasive or irrelevant.: Sheriff courts hear civil cases as a bench trial without a jury, and make determinations and judgments alone.

Community service may be ordered as a stand-alone sentence or as a condition of probation for many types of crimes, and in fact may be a required condition of punishment for crimes like looting or damaging property. However, community service is typically unavailable for serious offenses punishable by death or life imprisonment.
