The plan lays out how much each creditor will get paid, how long the plan will last, the values of the debtor's property, and more. The plan must be confirmed by the bankruptcy court in order for the case to proceed. The bankruptcy trustee and creditors can object to various aspects of the plan.

In a Chapter 13 bankruptcy, you and your lawyer submit a repayment plan for the court's approval laying out how you intend to repay your debts over a period of three to five years. The plan is largely calculated based on your household income,

deductions for various expenses like food and utilities, and other expenses like taxes and healthcare needs.
