File a claim against you in court. The EDD determines whether the recovery of an

For the Employment Development Department (EDD) to waive the penalty, the employer must establish that good cause or reasonable cause exists, based on the facts involved in the actual case. offset 25 percent of your weekly benefit payments. For fraud overpayments, the EDD will offset 100 percent of your weekly benefit payments. Since the EDD cannot offset the penalty portion of an overpayment from your benefits, you must repay the penalty separately.
